Illinois governor vetoes bill to raise the state's minimum wage to \$15

In an article posted by *CNN Money* the article states that the governor of Illinois has vetoed a bill that would have raised the state's minimum wage to \$15 an hour by 2022.

Gov. Bruce Rauner, a Republican, said in a veto message sent to the legislature that he considers the hike too severe.

The decision has incensed members of the Fight for \$15 movement, which have started to share messages on social media labeled #VetoRauner. He's up for reelection in 2018.

"The millions of underpaid workers in this state will remember Rauner taking To view and read entire article go to: food off our families' tables when we go to the polls in 2018," McDonald's worker Adriana Alvarez said in a statement on behalf of the group's Chicago chapter.

It's been 10 years since Congress raised the minimum wage, which has spurred many states and cities to take action themselves in recent years.

But Republicans lawmakers and officials have tried to stop many of the hikes when possible.

The article concludes by explaining that On Monday, August 28, 2017 a Missouri law that lowers St. Louis' minimum wage from \$10 to \$7.70 goes into effect.
